2024年10月24號: 加拿大移民部長最新公布，將會在未來三年大幅度削減加拿大移民人數。

現在每年接收500,000新移民計算，明年2025年若減少五分之一20%。亦即是減少約100,000新移民。2026年減少120,000，2027年減少135,000。亦即是在2025年只會接收39萬5千人。2026年只會接收38萬人，2027年只會接收36萬5千人，逐減接收人數。

根據宜家移民統計，每年幾十萬的新移民來自四個申請方法：第一種家庭類別申請或稱家庭團聚，主要申請夫妻父母子女來加，一般申請時間需要幾個月至一年不等，宜家移民統計每年約有42%用這個類別申請來加。另外42%以技術移民或打工移民作申請又或者以留學轉移民作申請；約6%以商業移民或投資移民或做生意移民作申請；剩餘10%是以難民及保護作申請。

宜家移民在各種申請類別都接近100%成功率，處理時間均在一星期以內處理完成初步申請所有資料。

NAVIGATING CHALLENGES IN CANADA'S IMMIGRATION POLICY TRENDS

October 24, 2024: Canada's Minister of Immigration recently announced that the number of Canadian immigrants will be significantly reduced over the next three years.



Currently, with an annual intake of 500,000 new immigrants, this number will be cut by one-fifth, or 20%, in 2025, resulting in a reduction of about 100,000 new immigrants. In 2026, the intake will decrease by 120,000, and by 135,000 in 2027. This means that only 395,000 people will be accepted in 2025, 380,000 in 2026, and 365,000 in 2027, reflecting a gradual decline in the number of accepted applicants.

According to HCDF statistics, hundreds of thousands of new immigrants come from four main application methods each year. The first is the family category, or family reunification, which primarily includes applications from couples, parents, and children seeking to come to Canada. Generally, the application process takes a few months to a year. Statistics indicate that about 42% of applicants apply under this category each year. Another 42% apply as skilled immigrants, worker immigrants or students, while about 6% apply as business or investment immigrants. The remaining 10% are refugees or applicants seeking protection.
