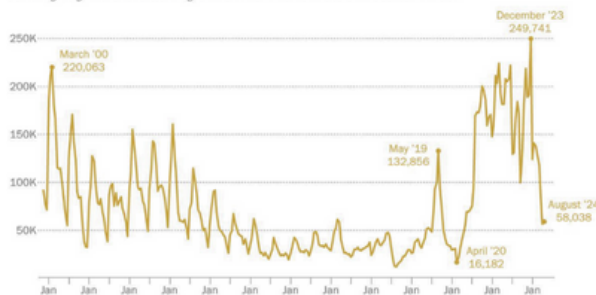

## 2025 年預計過百萬美墨邊境難民湧入

從2020年至2024年美國民主黨執政期間，通過美國與墨西哥邊境非法進入美國的移民人數已超過1000萬人，平均每月超過20萬人。雖然最近幾個月有下降的跡象，但相信在2025年1月共和黨新總統上任之前，會有更多的非法移民進入美國。美國的下一任總統川普已發表演說，將會驅逐所有非法移民（不包括合法移民）。在這即將發生的情勢下，預計其中一部分非法移民會被遣返至墨西哥或其他國家，但很可能有相當多的人會北上非法進入加拿大。

如果這些非法移民中有10%選擇北上進入加拿大，我們預計未來一年內，加拿大的非法移民人數可能會超過120萬人，是加拿大30年的移民配額人數，這相當於加拿大總人口的3%，是一個龐大且具風險的數字。宜家移民是首個向大家提出此風險的公司，基於36年以上的豐富經驗，我們建議聯邦政府儘快採取適當措施，應對即將來臨的挑戰。

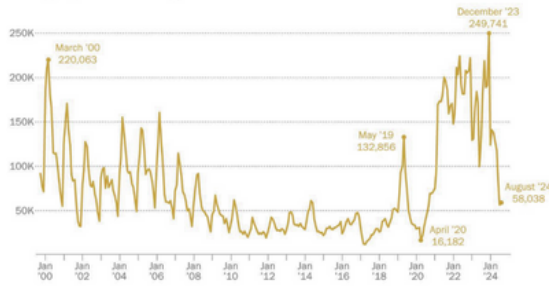

### Projected Surge of Over 1 Million Refugees at U.S.-Mexico Border in 2025

From 2020 to 2024, under the U.S. Democratic administration, more than 10 million individuals entered the United States illegally through the U.S.-Mexico border, averaging over 200,000 people per month. While there have been signs of a decline in recent months, it is expected that the number of illegal immigrants will rise again before the new Republican president takes office in January 2025. Donald Trump, the Republican nominee for the 2024 U.S. presidential election, has stated his plan to expel all illegal immigrants (excluding those with legal status).

In light of this imminent situation, it is expected that some of these illegal immigrants will be deported to Mexico or other countries. However, it is highly likely that a significant number will attempt to continue their journey north and illegally enter Canada.

If 10% of these illegal immigrants choose to head north into Canada, we estimate that the number of illegal immigrants in Canada could exceed 1.2 million within the next year. This would be equivalent to Canada's entire immigration quota for the past 30 years and represent approximately 3% of Canada's total population—a substantial and high-risk figure. HCDF Immigration Inc., with over 36 years of experience, is the first to bring this risk to public attention. We strongly urge the Canadian federal government to take immediate and appropriate action to address the upcoming challenges.

From a professional standpoint, HCDF Immigration Inc. believes that the number of refugee and protection applications will significantly increase in the coming years. We expect that the majority of refugees entering from the U.S.-Mexico border will file their applications in the Toronto and Vancouver regions. HCDF Immigration Inc. estimates that approximately 80% of these applications will be submitted in Toronto, while 20% will be filed in Vancouver. This could result in a sudden increase of up to 240,000 refugee applicants in Vancouver by 2025, which would exceed the city's expected workload for the next 10 years.
